



YOUTH COLT GIVEAWAY OPPORTUNITY

Description: The High Plains Ranchers and Breeders Association Annual Horse Sale, is doing a colt giveaway. A yearling colt of their selection will be offered up to a deserving applicant. The colt is not to be sold before reaching 2 year old status, and the applicant will be required to provide proof of training on a monthly basis (video and photo evidence). The winning applicant will have the opportunity to bring the colt back as a two year old for sale, or compete in the futurity as a three year old. This is not required, however. This experience is aimed at a student who is dedicated to learning about the care and training of a quality bred quarter horse.

The application will be due back to **Chisum Ranch: 2457 FM 1727, Dalhart, Texas 79022 in hand by May 31st, 2025**

The HPRBA Selection Committee will be in charge of picking the winner for this year.

[1] Eligibility Requirements

- Applicants must be between 15-19 years old.
- Applicants must have suitable housing for a young colt.
- Parent and applicant **must** be present for the HPRBA sale to pick up the colt. (June 8)
- Winning applicant will be required to provide proof of progress in the training journey up until the next annual HPRBA sale.
- Registration/papers are not transferable until the colt is 2 years of age.
